A BILL

- To align the United States International Development Finance Corporation with United States national security and strategic goals.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Aligning Development
 - 5 and Competition Act of 2024".
 - 6 SEC. 2. IMPROVING USIDFC TRANSPARENCY.
 - 7 Not later than 90 days after the date of the enact-
 - 8 ment of this Act, and annually thereafter, the Chief Exec-
 - 9 utive Officer of the United States International Develop-

1	ment Finance Corporation shall submit a report to the
2	Committee on Foreign Relations of the Senate and the
3	Committee on Foreign Affairs of the House of Representa-
4	tives regarding the Development Advisory Council of the
5	Corporation, which—
6	(1) lists any organization or entity that—
7	(A) employs, contracts for services with, or
8	otherwise provides compensation to, any mem-
9	ber of the Council; and
10	(B) has received support directly from the
11	Corporation through loans, loan guarantees,
12	grants, or other financial support since the sub-
13	mission of the prior report required under this
14	section; and
15	(2) with respect to each organization or entity
16	referred to in paragraph (1)—
17	(A) identifies the name of the member or
18	members of the Council to which it provides
19	compensation;
20	(B) describes the support provided by the
21	Corporation to the organization or entity since
22	the submission of the prior report required
23	under this section; and

1	(C) describes any actions that were taken
2	to address the existence or appearance of a con-
3	flict of interest.
4	SEC. 3. PRIORITIZING PROJECTS THAT ADVANCE NA-
5	TIONAL SECURITY.
6	Section 1412 of the BUILD Act of 2018 (22 U.S.C.
7	9612) is amended by adding at the end the following:
:8	"(d) PRIORITIZATION OF NATIONAL SECURITY IN-
9	TERESTS.—The Corporation shall prioritize the provision
10	of support under title II in projects that advance core na-
11	tional security interests of the United States with respect
12	to strategic competition with a covered nation (as defined
13	in section 4872(d)(2) of title 10, United States Code), in-
14	cluding port infrastructure, rail and other transportation
15	infrastructure, digital and communications infrastructure,
16	and critical minerals mining, production, and processing
17	materials and facilities.".
18	SEC. 4. INCLUSION OF SECRETARY OF DEFENSE IN USIDFO
19	BOARD OF DIRECTORS.
20	Section 1413(b)(2)(B)(i) of the BUILD Act of 2018
21	(22 U.S.C. 9613(b)(2)(B)(i)) is amended by adding at the
22	end the following:
23	"(V) The Secretary of Defense or
24	a designee of the Secretary.".

1	SEC. 5. STRATEGIC ADVISORY COUNCIL.
2	(a) ESTABLISHMENT.—Section 1413 of the BUILD
3	Act of 2018 (22 U.S.C. 9613) is amended—
4	(1) in subsection $(g)(2)(F)$ —
5	(A) by striking "established under sub-
6	section (i)" and inserting "and of the Strategie
7	Advisory Council,"; and
.8	(B) by striking "the Council" and insert-
9	ing "each such Council";
10	(2) in subsection (i)(4), by striking "the Fed-
11	eral Advisory Committee Act (5 U.S.C. App.)" and
12	inserting "chapter 10 of title 5, United States Code
13	(commonly known as the 'Federal Advisory Com-
14	mittee Act')"; and
15	(3) by adding at the end the following:
16	"(j) Strategic Advisory Council.—
17	"(1) In General.—There is established a Stra-
18	tegic Advisory Council (referred to in this subsection

22	"(2) Membership.—Members of the Council
.23	shall be appointed by the Board, on the rec-
24	ommendation of the Chief Executive Officer, and
25	shall be composed of not more than 9 members
26	broadly representative of governmental or non-

governmental organizations, think tanks, founda-1 tions, associations, and other institutions focused on 2 3 national security, including areas of strategic com-4 petition, the defense industrial base, and national 5 and homeland defense. 6 "(3) Functions.—The Board shall call upon 7 members of the Council, either collectively or indi-8 vidually to advise the Board regarding the extent to 9 which the Corporation is supporting the national security and foreign policy objectives of the United 10 11 States and provide any suggestions for improve-12 ments with respect to supporting such objectives, in-13 cluding opportunities in countries and project development and implementation challenges and opportu-14 15 nities. "(4) FEDERAL ADVISORY COMMITTEE ACT.— 16 17 The Council shall not be subject to chapter 10 of 18 title 5. United States Code (commonly known as the 19 'Federal Advisory Committee Act').". 20 (b) Consultation.—Section 1442(d) of the BUILD Act of 2018 (22 U.S.C. 9652(d)) is amended by striking "established under section 1413(i)" and inserting "and 22 the Strategic Advisory Council established under sub-

sections (i) and (j) of section 1413".

1 SEC. 6. VITAL NATIONAL SECURITY INTERESTS WAIVER.

- 2 Section 1421 of the BUILD Act of 2018 (22 U.S.C.
- 3 9621) is amended by adding at the end the following:
- 4 "(j) VITAL NATIONAL SECURITY INTERESTS WAIV-
- 5 ER.—The Chief Executive Officer may waive the require-
- 6 ments of subsection (a)(1) that a project supported by the
- 7 Corporation occur in a less developed country and the re-
- 8 quirements of section 1412(c) for a particular project if
- 9 the President determines that such a waiver is in the vital
- 10 national security interests of the United States.".
